

**SECOND AMENDMENT TO  
TYPE 1 CHARTER SCHOOL OPERATING AGREEMENT  
BRICOLAGE ACADEMY  
AND THE ORLEANS PARISH SCHOOL BOARD**

This Second Amendment to Type 1 Charter School Operating Agreement (hereinafter, "Amendment") is hereby entered into on the 3<sup>rd</sup> day of May, 2016, by and between the Orleans Parish School Board, a political subdivision of the State of Louisiana located at 3520 General de Gaulle Drive, Suite 5055, New Orleans, Louisiana 70114, herein represented by Seth Bloom, its President, duly authorized ("Authorizer" or "OPSB"), and the Bricolage Academy a Louisiana Non-profit Corporation located at 3368 Esplanade Avenue, New Orleans, Louisiana 70119, herein represented by Alan Philipson, its Board President, duly authorized (hereinafter "Charter School"). Authorizer and Charter School are collectively referred to as "the Parties."

**WITNESSETH**

WHEREAS, effective July 1, 2013, Authorizer and Charter School entered into a Type 1 Charter Operating Agreement (hereinafter "Operating Agreement"); and,

WHEREAS, on March 2, 2016, the Board of Directors of Charter School voted to support an amendment to said Operating Agreement to allow Charter School to grant a preference to students identified as "economically-disadvantaged," as defined in La. R.S. 17:3991, in order to ensure that not less than one-third of all seats at the school are provided to such students and voted to request OPSB's consent to such amendment; and,

WHEREAS, on March 15, 2016, at a duly called business meeting, OPSB voted to authorize an amendment to Charter School's Operating Agreement to provide for said student preference; and,

WHEREAS, Authorizer and Charter School now desire to amend the Operating Agreement to provide for a preference in the common enrollment process for students identified as "economically-disadvantaged."

NOW THEREFORE, the Parties hereby amend the Operating Agreement as follows:

I.

Appendix 2: School-Specific Terms, Section 2 is amended to read as follows:

**Enrollment.** Bricolage supplements the Common Application Form and Timeline with the following school specific admissions policies and procedures:

- a) Preferential admission is given to children of Bricolage faculty and staff members and siblings of current Bricolage students who meet the residency and age requirements.
- b) Charter School shall grant admissions preference for at least 33% of seats to students who are designated as "economically-disadvantaged."
- c) Bricolage does not use any academic assessments or criteria in an academic matrix for student selection


All of the terms and conditions of the Operating Agreement shall remain in full force and effect, except as specifically amended hereinabove.
